DOW daily: We have a DECISION to make here given we are about to TEST the more MAJOR moving averages. Fail here and the drop will have a lot of MOMENTUM.






CCMP daily: We are teasing the 50 day moving average - 23.6 % ret 13951, so keen to see how we DO HERE.
