

US STOCKS : **ALL EYES ON EQUITIES HERE**

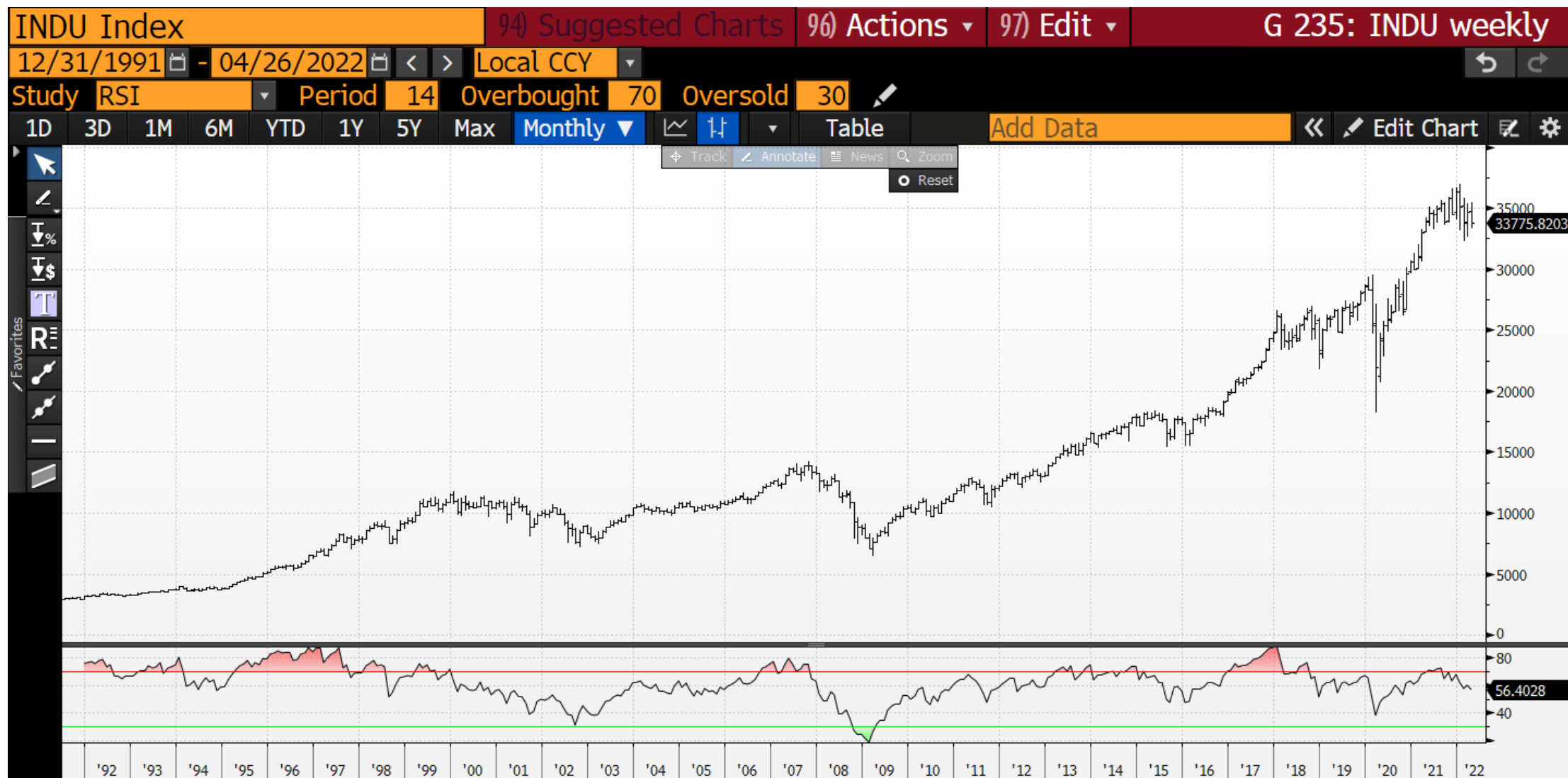

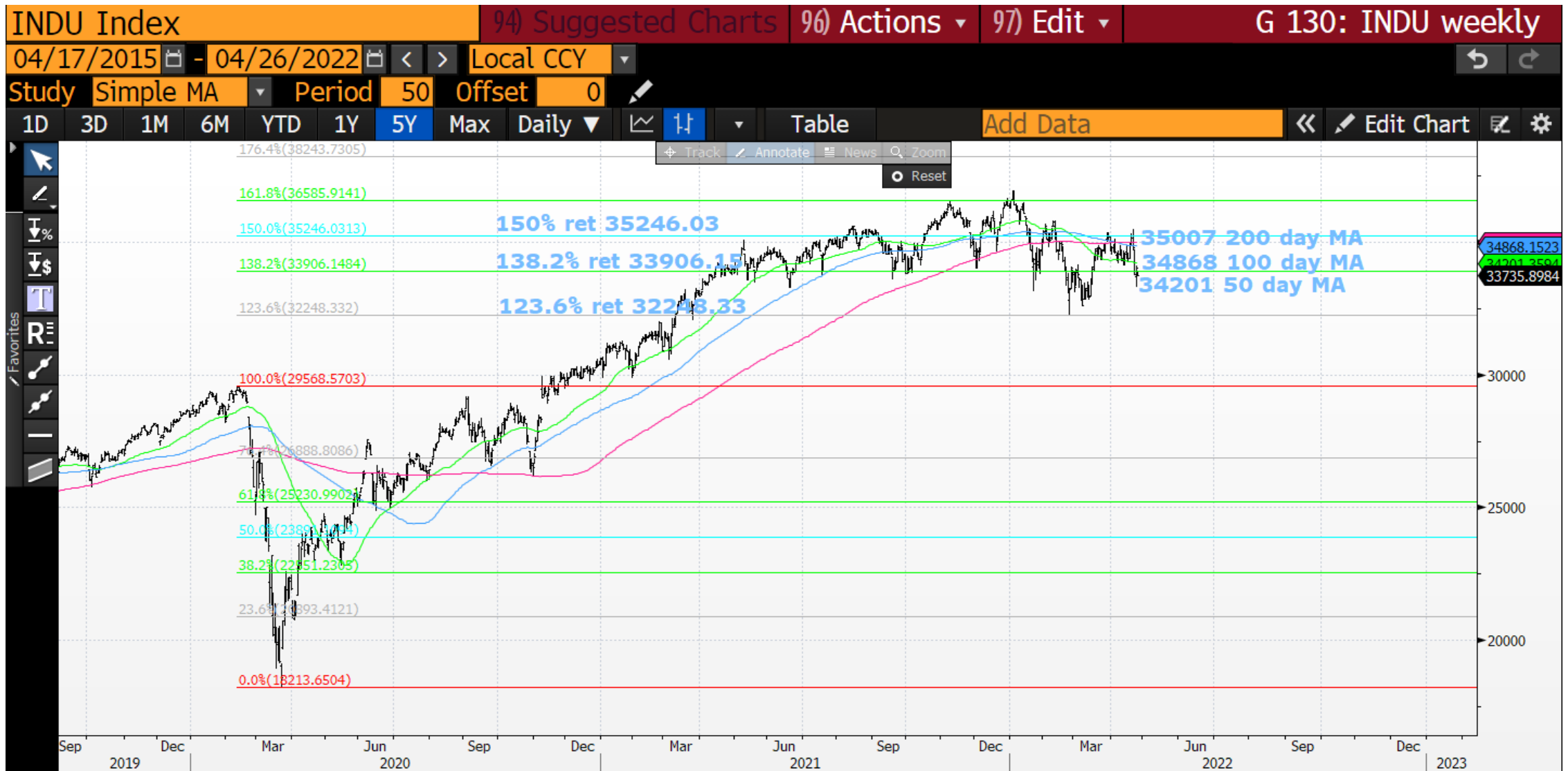

DOW daily : Despite the previous chart we are now SUB ALL moving averages. The big prize will be to BREACH the 123.6% ret 32248.33.



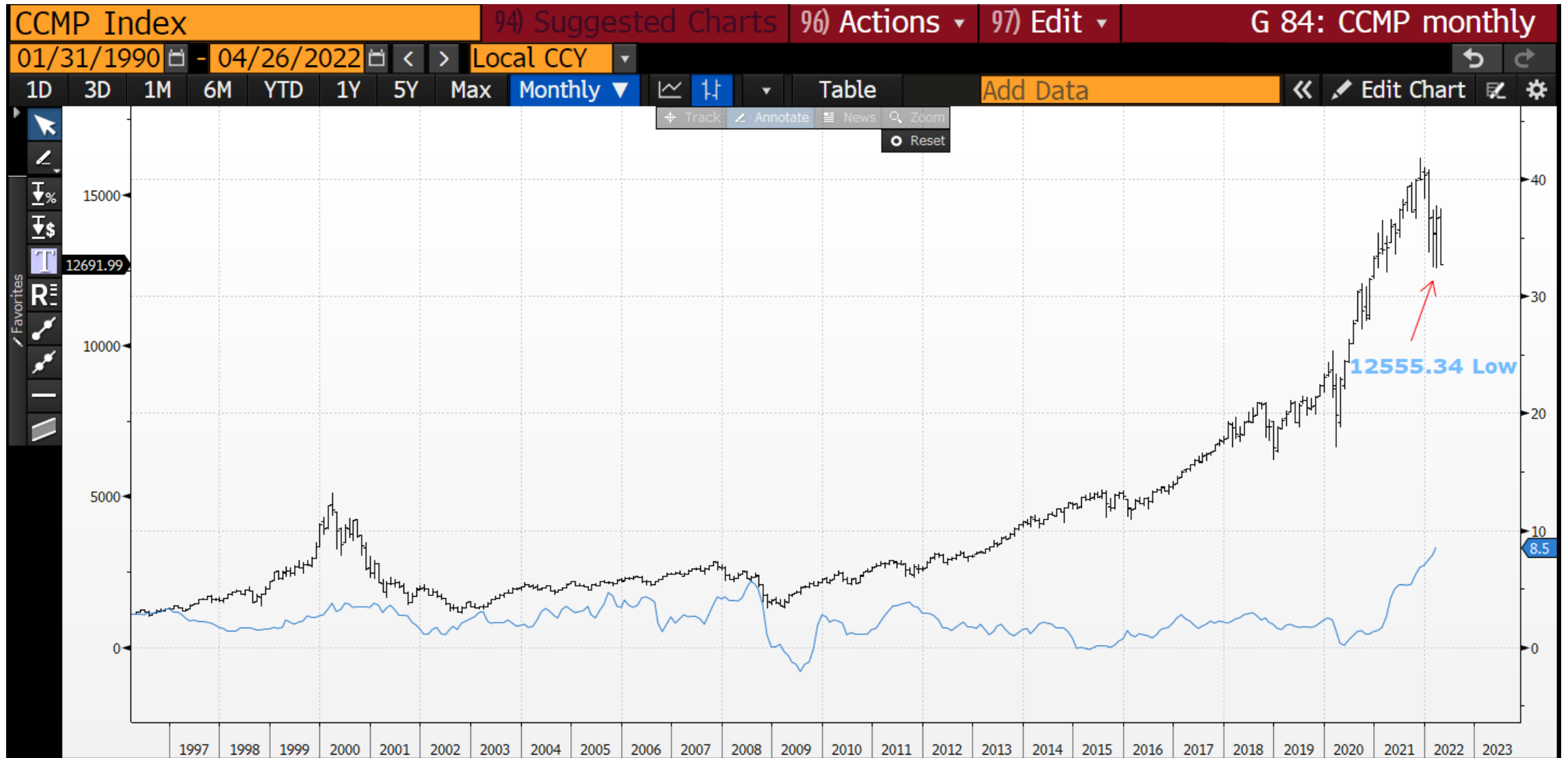

Russell daily : We are SUB ALL moving averages and ideally breaching the 123.6% ret 1891.80 soon.



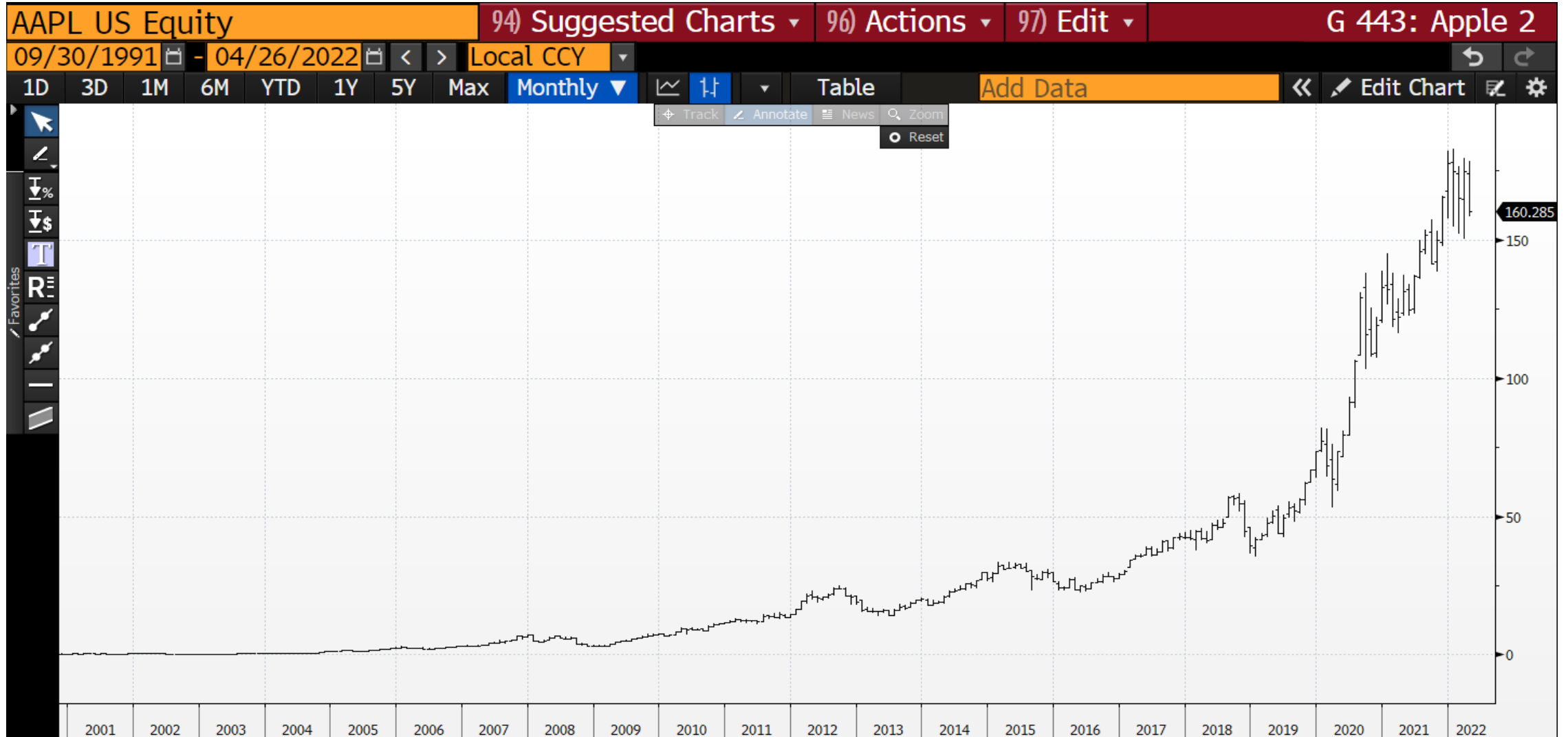
CCMP and CPI overlay monthly : ONE to WATCH especially if we BREACH the recent LOW 12555.34!



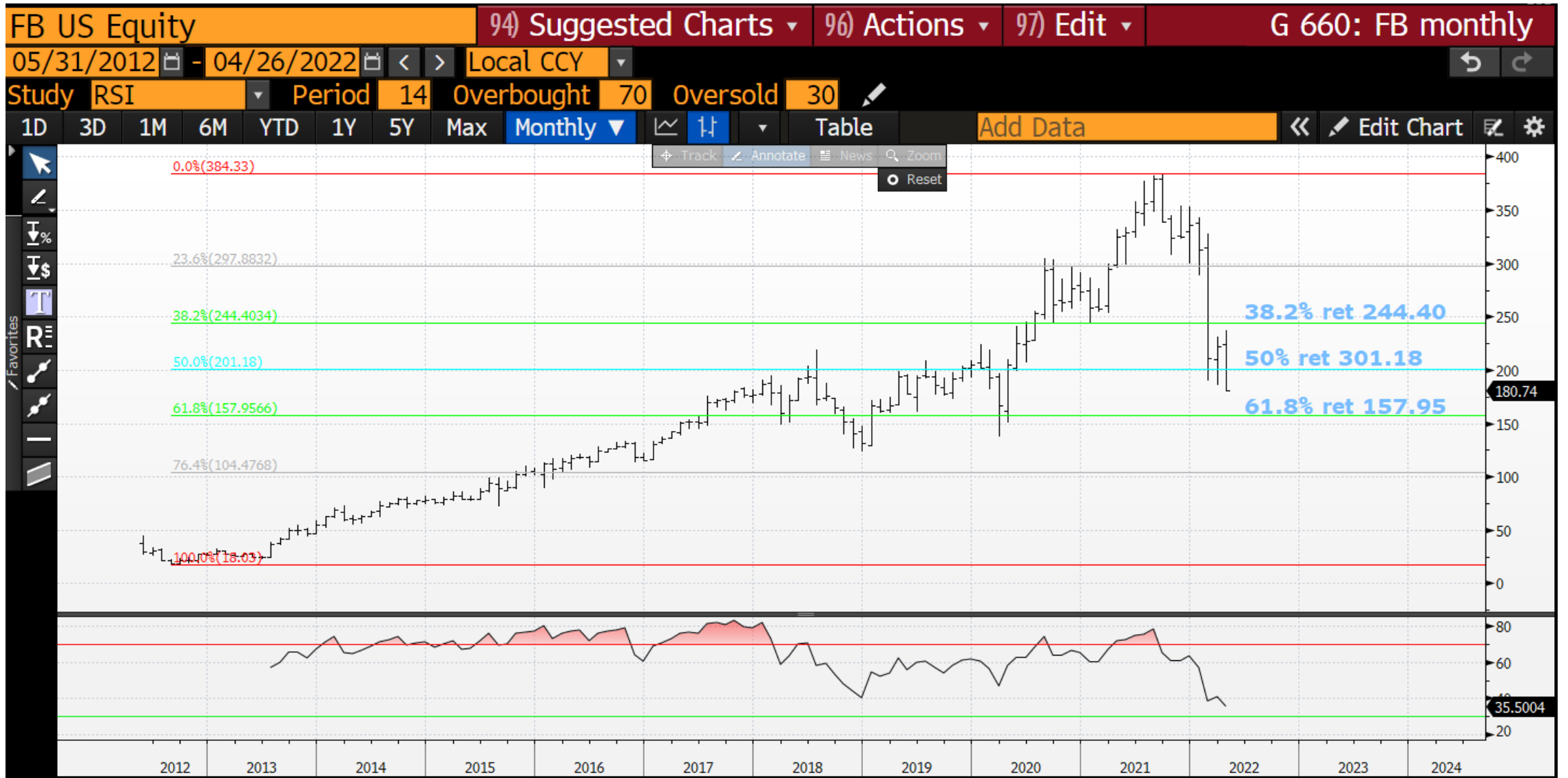
CCMP daily : We are SUB all moving averages and hopefully going to TEST the 38.2% ret 12552 previous support.

FACEBOOK monthly : No MAJOR bounce and making a NEW LOW already!



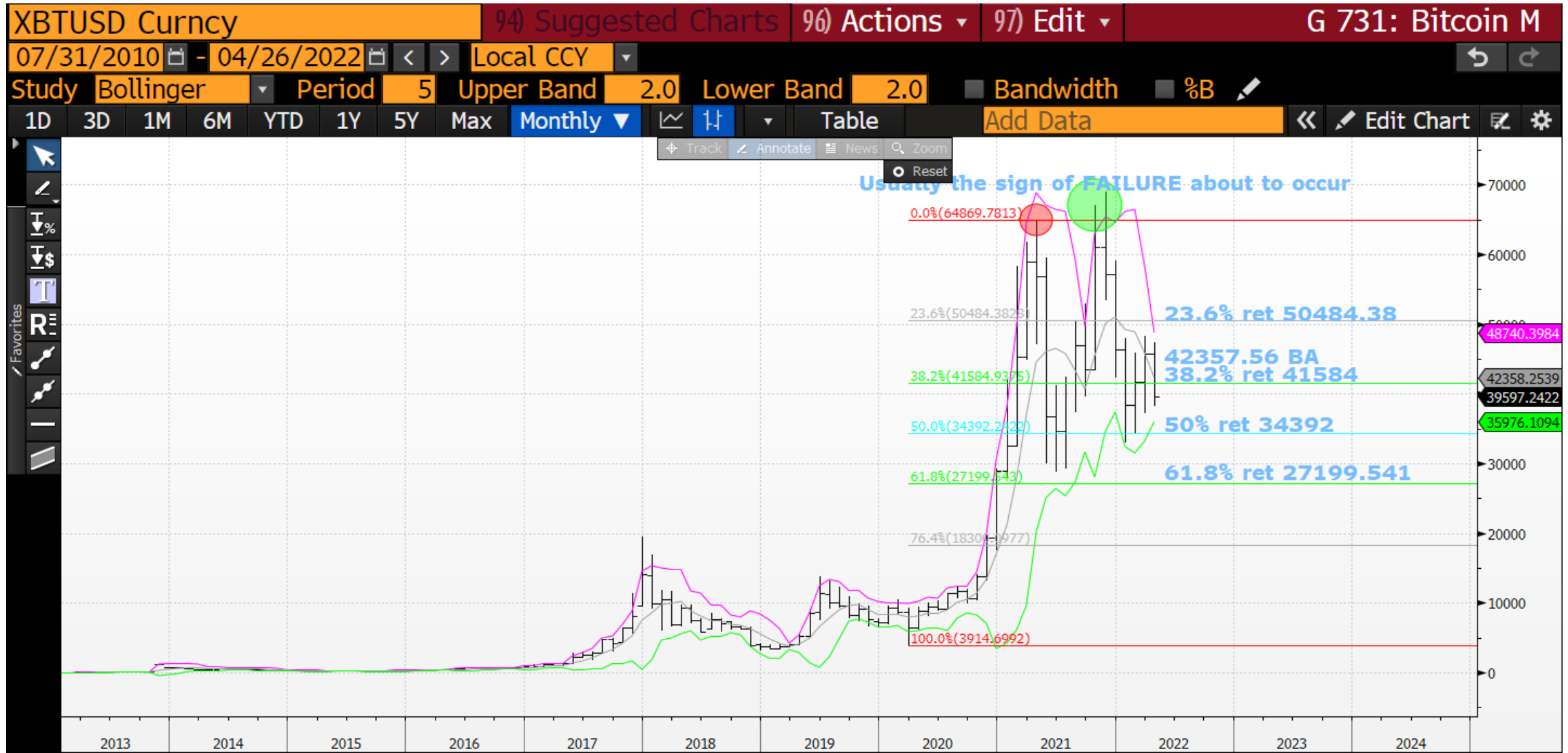
INTEL monthly : ** ONE TO WATCH ** We are EDGING CLOSER to the MASSIVE FALLOUT AREA if 42.04!
